### LEADERSHIP AND ADMINISTRATION:

*Founding Chair, MSU College of Human Medicine's Charles Stewart Mott Department of Public Health in Flint, Michigan, April 2024 - present. Founding faculty member, Jan 2015 – present. As the founding member and search lead of the MSU's Division of Public Health (which began when I came to an empty building 9 years ago), I set the tone for the now Department's pursuit of excellence and commitment to community-partnered institutional administration. I insisted that we could attract many more R01-level researchers, and then I found them. In the 9 years since I came, we have hired at least 20 more faculty (including full professors from the #1 and #4 public health schools in the country), 100+ staff members and we have received more than \$170 million*

in grant funding and 3 NIH-funded Center grants. When I stepped down as search chair, faculty were 70% female and 46% under-represented minorities.

*Chair, Michigan State University Faculty Senate and University Steering Committee, Aug 2020 – Aug 2021. Vice Chair, Aug 2019 – Aug 2020; Steering Committee At Large Member, July 2018 –Aug 2021.* I led the work of University Faculty Governance (consisting of 100+ faculty and student representatives and 10+ subcommittees), representing 5,722 university faculty and academic staff to the President, Provost, and Board of Trustees on the highest governing board of the university (appointed by university-wide election). Issues addressed included: (1) enacted tracking of diversity, equity, and inclusion (DEI) metrics and DEI statement requirements for in academic governance; (2) motions advancing DEI at the university generally; (3) reorganized the Office of Academic Governance; (4) created operating procedures to make communication among shared governance, administrators, faculty, and students more efficient and effective; (5) university budget and re-opening in the context of COVID; (6) a clearer, safer, more responsive university climate; (7) promoted faculty voice in a President and a Provost search and in university Strategic Planning; (8) revised university bylaws; (9) made MSU a signatory on #TimesUp Healthcare; (10) organized academic governance processes (created Faculty Senate Orientation, organized tracking and accountability, began email updates to all university faculty; conducted the first annual Academic Governance diversity survey, increased Faculty Senate attendance from 77% to 91%, changed norms to focus on actions/solutions), and (11) addressed >40 other issues in the year I was chair.

*President's Strategic Planning Committee, Michigan State University, Dec 2019 – Sept 2021.* The committee determined the university's vision, values, and strategic direction with input from campus and external stakeholders, including alumni and community leaders. I led the values subcommittee, charged with clarifying university values, and serve on the 6-member President's Ad Hoc Values Integration Working Group. I was also a member of the resource subcommittee, charged with informing the university's future resource allocation model, of the Health Pillar goals committee. <https://president.msu.edu/initiatives/strategic-plan/steering-committee.html>.

*Chief Translation Officer, Michigan State University Office of Health Sciences, Sept 2023 – current.* In this role, I provide consultative advice to the Executive Vice President for Health Sciences to identify, develop, and champion key initiatives in the Office of Health Sciences, including advancement of the University strategic plan, clinical and translational science efforts, and gun violence initiatives, helping to ensure that innovation reaches and provides value to the the communities we serve.

*Organizer, convener, and lead (with Dr. Claudia Finkelstein) of Michigan State University College of Human Medicine "CHM and Reaching the Vulnerable" Workgroup, July 2018 – May 2022.* This workgroup consists of associate deans and other College leaders. It ensures that the College is meeting its mission to serve the vulnerable. We are working to make the College trauma informed, and have organized a speaker series, small group dialogues around difficult topics, suggestion boxes, and a platform to match sexual assault survivors to opportunities to participate in ongoing university decision-making. *The National Center for Health and Justice Integration for Suicide Prevention (NCHATS)*  
This national practice-based research center, including academic, health, and justice institutions and over 100 Consortium Partners, examines effectiveness, cost-effectiveness, and scalability of suicide prevention activities triggered through justice-health big data linkage. The Center: (1) uses contact with the justice system (e.g., police contact, court involvement, arrest) as an indicator of suicide risk in the general population; (2) demonstrates how big data systems that efficiently track publicly available data on justice involvement can be linked to health system records to identify individuals at risk for suicide and connect them to community care; and (3) examines effectiveness and scalability of suicide prevention approaches using these methods.

*Administrative Core (Johnson, Ahmedani and Weinstock).* This Core oversees: (1) Center strategic planning, (2) scientific leadership and oversight; (3) logistical and administrative support to the Center components, and (4) facilitation of a network of Consortium Partner stakeholders affiliated with the Center.

*Methods Core (Johnson)*. This Core provides national expertise and resources needed to conduct rigorous, reproducible research projects that share similar conceptual frameworks, methods, and measures.

*Project 1: Syncing screening and services for suicide prevention across health and justice systems* (Ahmedani and Weinstock). In this project, two large health systems (Henry Ford and HealthPartners) identify justice involvement of their patients and act to prevent suicide (n = 61,500).

*\*Project 2: Managed care updates of subscriber justice system involvement for suicide prevention* (Arias and Johnson). In this project, a Medicaid managed care organization (CareSource) identifies justice involvement of its subscribers and acts to prevent suicide (n = 43,000).

*Project 3: Using jail populations to validate an established suicide risk algorithm* (Kubiak and Ahmedani). In this project, Michigan jails will identify suicide risk at initial detention or community re-entry using Medicaid data and act to prevent suicide (n = 6,000).

*Project 4: Improving mental health treatment for individuals in crisis interacting with the criminal justice system* (Cook and Barrett). This project evaluates police-emergency department partnership for suicide risk identification and preventive action (n = 1,057).

*Pilot project 1: Understanding and addressing suicide stigma and misinformation among criminal legal practitioners* (Hulsey). This project works with criminal-legal practitioners to identify and correct myths about suicide and suicidality that prevent their participation in suicide prevention activities.

*Pilot project 2: Piloting a family law navigation model to prevent suicide and increase update of mental health service use for youth and their families* (Rudd). This project evaluates feasibility of working with families in family court for suicide prevention.

*Pilot project 3: Crisis diverted: Adapting scalable crisis response interventions for people involved in a criminal legal system diversion program* (Athey). This project will develop and pilot test a combined Crisis Line Facilitation and Take Home Naloxone program for criminal-legal system involved adults.

*Pilot project 4: Disrupting black girl suicide: From meta-analysis to qualitative interviews* (Meza, Lee). This project will conduct a meta-analysis and quantitatively and qualitatively to characterize structural risk and protective factors for suicide among Black girls.

*Maternal Health Multilevel Interventions for Racial Equity (MIRACLE) Center*

This Center will reduce pregnancy-related and pregnancy-associated maternal morbidity and mortality (PRAMM) disparities in African American, Hispanic, and rural populations through innovative and culturally relevant community-partnered effectiveness and implementation research. The Center tests multilevel, community-centered, equity-focused interventions for PRAMM disparities, with an emphasis on scalability and sustainment. Ideas for the Center and Center projects either came from or were co-developed with community, and there are academic and community PIs of every project and the Center overall.

*Project 1: Multilevel community-centered intervention to reduce pregnancy related and associated morbidity and mortality (PRAMM) disparities in non-Hispanic Black and Hispanic Medicaid-insured individuals* (Meghea, Slaughter-Acey, Wisdom). This project is the first large-scale test of a home visiting program that integrates community health workers to focus on PRAMM disparities issues, including comorbid conditions. It will address patient-provider interactions from provider and patient perspectives. Role: Co-I

*Project 2: High reach, multi-level digital intervention for pregnancy-related and - associated morbidity and mortality (PRAMM) disparities* (Ondersma, Margerison, McKay). This project develops and tests the effectiveness of a technology-enabled approach to reducing PRAMM disparities among rural and African American populations. Role: Co-I

*Project 3: Scale-up implementation approaches to ending pregnancy-related and - associated morbidity and mortality (PRAMM) disparities* (**Johnson**, Clement). This project will develop and evaluate the effectiveness and cost-effectiveness of a scale-up implementation approach for scaling equity-focused outpatient and community care safety bundles county-wide in 12 Michigan counties with a population of nearly 6 million people. Role: PI

*Community Partnership Consortium* (Key, Sanchez-Lloyd). This Consortium will create an action-oriented, inclusive, broad-based stakeholder group to act as full partners in increasing the relevant and reach of Center activities. Role: Co-I

The Center will engage and prepare early-stage investigators, especially those from backgrounds or identities currently underrepresented in the health sciences, to conduct research that address the biological, behavioral, environmental, and structural determinants of PRAMM disparities. ROSE is an evidence-based intervention that prevents half of cases of postpartum depression. It was recommended by the US Preventive Services Task Force in 2019. This n=2,320 project assesses effectiveness, cost-outcome, equity, and scalability of using ROSE as universal vs. targeted prevention for postpartum depression. Results will indicate whether all pregnant women or only those at risk for postpartum depression should receive ROSE.

We will test the intervention using data from all Medicaid insured women who deliver in Michigan from 2016-2019 and 2021–2024 (approximately 540,000 births, including 162,000 births to African American women).

1. **Flint Women's Study, Lead and Principal Investigator.** The goal of this community-engaged participatory research and advocacy project was to determine the hopes, dreams, needs, strengths, and assets of women in Genesee County (n = 100 qualitative interviews), and then to re-convene study participants and others to create community initiatives to address needs and build on assets together. <https://www.publichealth.msu.edu/flint-research/the-flint-women-s-study>

At the direct suggestion of participants in the Flint Women’s study, the Center was created as a place for women to gather, have opportunities to develop self-confidence, and address other issues identified in the study. Results of the Flint Women’s Study also led to a county-wide summit on human trafficking (“Myths, Facts, Prevention, and Action”) on 9/24/2020, and have informed many other community initiatives, including grantmaking. My team also maintains an [up-to-date community resource guide](#).
  - **Organizer,** Healthy Bodies Start with Healthy Minds: A community conversation about mental health. The goal of this workshop was to give community members an opportunity learn about mental health and mental health care in a non-stigmatizing way. It arose directly from participant suggestions in the Flint Women’s Study.
2. **Criminal justice/mental health knowledge translation.** R01 MH118680, in partnership with the national Stepping Up Initiative, has created several knowledge translation products to benefit counties. First, we provided a tailored county feedback report/report card for the 504 counties that completed the first wave of the study. The report card was developed and its usefulness and readability maximized through several rounds of suggestions and feedback from Stepping Up Innovator counties. The report card includes the mutual conceptual model for the Initiative and the Study; a list of evidence-based policies, practices, and treatments showing which the county offers and what percent of U.S. counties offer each practice/treatment; county progress on key quality improvement efforts; and suggestions for next steps for the county.
  3. **National webinar series** on improving services for individuals at the intersection of law enforcement, mental health, and the justice system through R01 MH118680. Nearly 1400 practitioners and policymakers have attended as of 10/1/2022. Topics have included, “Understanding evidence-based treatments for justice-involved individuals with mental illness” (9/15/2021) and “Criminal level system behavioral health evidence-based practices (10/12/2022). The goal is to help community mental health, substance use, jail, probation, and other county leaders attending to work together better to keep individuals with mental illnesses out of jail.
